ORDER

The Apex Committee of AMRUT has approved a total number of **255 projects** for Water Body Rejuvenation, amounting to Rs. 82.354 crore, submitted under Tranche II. Following cancellations and replacements, the final number of approved projects stands at 248, with a total cost of Rs. 82.94 crore (Capex: Rs. 77.25 crore; O&M: Rs. 5.69 crore). Administrative Sanction has been accorded for 239 of these projects, amounting to Rs.75.94Cr. (Capex Rs.70.64Cr, O&M- Rs.5.30 Cr.). The Apex Committee of AMRUT has also approved a total number of 123 for water body rejuvenation, amounting to Rs. 62.14 crore (Capex: Rs. 59.33 crore; O&M: Rs. 2.81 crore), and 73 projects for parks and green spaces, amounting to Rs. 40.72 crore (Capex: Rs. 36.4 crore; O&M: Rs. 4.33 crore), submitted under Tranche III.

2. The 10th State Level High Powered Steering Committee (SHPSC) of AMRUT has considered DPRs of 128 projects amounting to Rs. 65.652 crore (Capex Rs. 62.66 Crore and O&M - Rs. 2.992 Crore) under Water Body Rejuvenation Sector (Tranche II & III), and DPRs of 65 projects amounting to Rs. 34.942 Crore (Capex Rs.31.56Cr; O&M- Rs. 3.382Cr.) under the Parks and Green Spaces Development Sector (Tranche III), for according Administrative Sanction.

Based on the recommendation of SLTC of AMRUT as per the minutes read as 1st paper above, 10th SHPSC has decided to accord Administrative Sanctions for 128 Water Body Rejuvenation projects, amounting to Rs. 65.652 Crore (CAPEX: Rs. 62.66 Crore; OPEX: Rs. 2.992 Crore) and 65 Parks and Green Spaces Development projects, amounting to Rs. 34.942 Crore (CAPEX: Rs. 31.56 Crore; OPEX: Rs. 3.382 Crore), subject to the following conditions,

- ❖ Central Assistance will cover only the Capital Expenditure (CAPEX) and will not extend to Operational & Maintenance (OPEX) costs or land acquisition expenses.
- All projects, including religious pond rejuvenation, must serve the public interest and secure all necessary regulatory clearances before commencement.
- ❖ Any costs exceeding the allocated SWAP amount must be funded by the respective Urban Local Bodies (ULBs).
- ❖ ULBs should implement measures to ensure that water bodies remain consistently clean and well- maintained.
- ❖ ULBs shall ensure adequate funding for the maintenance, development, preservation, and upkeep of park
- 4. As per the letter read as 2 nd paper above the Mission Director, AMRUT has requested to accord sanction based on the decision of 10th SHPSC of AMRUT read as 1st paper above.
- 5. Government have examined the matter and are pleased to accord to accord Administrative Sanctions for 128 Water Body Rejuvenation projects, amounting to Rs. 65.652 Crore (CAPEX: Rs. 62.66 Crore; OPEX: Rs. 2.992 Crore) approved under Tranche II & III and 65 Parks and Green Spaces Development projects, amounting to Rs. 34.942 Crore (CAPEX: Rs. 31.56 Crore; OPEX: Rs. 3.382 Crore) approved under Tranche III, appended as Annexure to this GO, subject to the following conditions,
- ❖ Central Assistance will cover only the Capital Expenditure (CAPEX) and will not extend to Operational & Maintenance (OPEX) costs or land acquisition expenses.
