## **ORDER**

As per G.O read as 1<sup>st</sup> paper above, Administrative Sanction has been accorded for the following two water supply projects in the Haripad Municipality under AMRUT 2.0

i) AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality– Construction of 9 LL OHSR at Thrippakudam- (AS Amount- Capex-Rs. 4.08 Cr. & O&M - 0.2 Cr., Project cost- Rs. 4.28 Cr.)

ii) AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality -Laying transmission main to newly proposed OHSR at Thrippakudam – (AS Amount- Capex 0.675 Cr. & O&M -0.01 Cr., Project Cost- 0.685 Cr.)

2. Initially, the two works were tendered separately, but due to a lack of bidders, Kerala Water Authority (KWA) decided to recast the estimate and issue a revised technical sanction. As a result, both works were combined and tendered as a single bid and the work has been arranged.

3. As per the minutes read as 2<sup>nd</sup> paper above, the 10<sup>th</sup> SHPSC of AMRUT has decided to accord Administrative Sanction for the combined project -AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality -

Construction of 7 LL OHSR at Thrippakudam & Laying transmission main to newly proposed OHSR at Thrippakudam for Rs. 4.965 Cr. (CAPEX-4.755 Cr. & OPEX- Rs.0.21 Cr.) in place of the two projects approved vide G.O read as 1<sup>st</sup> paper above.

4. As per the letter read as 3 <sup>rd</sup> paper above, Mission Director, AMRUT has requested to accord Administrative Sanction for the work- AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality - Construction of 7 LL OHSR at Thrippakudam & Laying transmission main to newly proposed OHSR at Thrippakudam for Rs. 4.965 Cr.(CAPEX-4.755 Cr. & OPEX- Rs. 0.21 Cr.). Mission Director, AMRUT has also requested to cancel the Administrative Sanction accorded for the above mentioned two projects of Harippad Municipality,vide G.O read as 1st paper above

Government have examined the matter and are pleased to accord Administrative Sanction for the combined project -AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality - Construction of 7 LL OHSR at Thrippakudam & Laying transmission main to newly proposed OHSR at Thrippakudam for Rs. 4.965 Cr. (CAPEX-4.755 Cr. & OPEX- Rs.0.21 Cr.)

i) AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality – Construction of 9 LL OHSR at Thrippakudam for Rs. 4.28 Cr. (CAPEX Rs. 4.08 Cr. & O&M -0.2 Cr.),

ii) AMRUT 2.0 - UWSS to Haripad – WSS to Haripad Municipality - Laying transmission main to newly proposed OHSR at Thrippakudam for Rs. 0.685 Cr. (CAPEX- 0.675 Cr. & O&M -0.01 Cr.).
