ORDER

As per the letter read as 3 rd paper above, Ministry of Housing and Urban Affairs, GoI has conveyed the Mother Sanction for an amount of Rs.56,70,04,000/- (Rupees Fifty-Six Crore Seventy Lakh Four Thousand only) as Central Share under SNA SPARSH towards the 1st installment of AMRUT for the implementation of the projects approved under SWAP - 2 & 3 of Kerala.

2. As per the letter read as 4th paper above, Mission Director, AMRUT has reported that an amount of Rs.133,41,81,000 (Rupees One Hundred Thirty Three Crore Forty One Lakh Eighty One Thousand Only) has to be released (including the Central and matching State share) towards the 1st

installment of AMRUT for the implementation of the projects approved under SWAP - 2 & 3 of Kerala

- 3. As per G.O read as 5 th paper above, sanction has been accorded for the release of an amount of Rs.1,16,00,00,000/- (Rupees One Hundred and Sixteen Crore Only Central share along with State share) under SNA SPARSH, towards the 1st installment for the implementation of the projects approved under SWAP-2&3 of AMRUT, from the the budget head of state share to the Mission Director, AMRUT.
- 4. As per the minutes of meeting read as 1 st paper above, on Implementation of SNA SPARSH the available provisions in Central h/a (01) may be re-appropriated to State h/a (02), for only those schemes which are on-boarded in SNA SPARSH in this FY, for which SNA concerned shall furnish proposals to Government.
- 5. As per letter read as 4 th paper above, Mission Director AMRUT has requested to take necessary action for re appropriation of available provisions in Central h/a to State h/a for the release of balance amount of Rs.17,41,81,103/- as detailed below:-
