ORDER

As per the letter read as 2nd paper above, Ministry of Housing and Urban Affairs, GoI has conveyed the Mother Sanction for an amount of Rs.56,70,04,000/- (Rupees Fifty-Six Crore Seventy Lakh Four Thousand only) as Central Share under SNA SPARSH towards the 1st installment of AMRUT for the implementation of the projects approved under SWAP - 2 & 3 of Kerala.

2. As per the letter read as 4^{th} paper above, Mission Director, AMRUT has reported that an amount of Rs.133,41,81,000 (Rupees One Hundred Thirty Three Crore Forty One Lakh Eighty One Thousand Only) has to be released (including the Central and matching State share) towards the 1^{st} installment of AMRUT for the implementation of the projects approved under SWAP - 2 & 3 of Kerala

3. As per the minutes read as 1st paper above, it has been decided that in the current FY, the bills for SNA SPARSH may be prepared only through State h/a (02 heads) of corresponding State Linked Scheme (SLS), for schemes having both Central/State shares. (ie, both Central and State share amounts shall be drawn from the 02 heads).

5. As per the circular read as 2nd paper above, upon receipt of a Mother Sanction from the Ministry for a scheme, the CCO/SCO concerned shall allocate required funds to the DDOs designated for the State Linked Scheme (SLS) for incurring expenditure under respective heads of account.

6. As per the letter read as 4 th and 5th paper above, Mission Director, AMRUT has requested to assign Mission Director, AMRUT as SCO for the respective Heads of Account for the transfer of funds to DDOs of

concerned ULBs and release Rs.1,16,00,00,000 /- (Rupees One Hundred and Sixteen Crore Only - Central share along with State share) from the budget provision available under respective heads of state share

7. As per G.O read as 6th paper above, Mission Director has been declared as SCO of Major Head - 2217, under Principal Secretary, LSGD for carrying out SCO function in respect of AMRUT Schemes (SCO Code-67DL01).

Government have examined the mater in detail and are pleased to accord sanction for the release of an amount of Rs.1,16,00,00,000/- (Rupees One Hundred and Sixteen Crore Only - Central share along with State share) under SNA SPARSH, towards the 1^{st} installment for the implementation of the projects approved under SWAP-2&3 of AMRUT, from the the budget head of state share to the account of Mission Director, AMRUT, the SCO of Major Head – 2217 *with SCO Code- 67DL01*, as detailed below;
