#### **ORDER**

10<sup>th</sup> State Level High Powered Steering Committee (SHPSC) Meeting of AMRUT 2.0 has considered 3 proposals from Municipalities of Kottakkal, Mattannur and Vaikom to cancel the projects for Water Body Rejuvenation/ Parks and Green Spaces approved by Apex Committee of AMRUT under SWAP 2&3 and replacement of projects as detailed below.

## A. Projects for Cancellation:

- 1. Water Body Rejuvenation Program for Municipal Pond in Kottakkal Municipality (Tranche II).
- 2. Mattannur-Green Space Park at Poongottu Kavu (Tranche III), Kolari Ward.
- 3. Vaikom Municipality Park and Green Spaces Construction of Park on the North Side of K V Canal (Tranche III).

### **B.** Projects for Replacement:

- 1. Kottakkal Water Body Rejuvenation Program for Kottakkal Raja's High School Public Pond.
- 2. Mattannur AMRUT 2.0 Green Space Park at Karithoor Parambu, Mattannur Municipality.
- 3. Vaikom AMRUT 2.0 Park and Green Spaces Construction of Park on the banks of KV Canal, Ayyarkulam, Kaniyanthodu, and Vallakadavu,

2. Based on the recommendation of SLTC, as per the minutes read as 1<sup>st</sup> paper above, 10<sup>th</sup> SHPSC of AMRUT 2.0 has decided to cancel the above mentioned projects approved by Apex Committee of AMRUT under Water Body Rejuvenation and Parks; and accord Administrative Sanction for the replacement projects as detailed below;

- 1."AMRUT 2.0 Water Body Rejuvenation Program for Kottakkal Rajas High School Public Pond" for Rs. 0.4754 Crore (CAPEX: Rs. 0.4454 Crore; O&M: Rs. 0.03 Crore) in Kottakkal Municipality.
- 2. "AMRUT 2.0 Green Space Park at Karithoor Parambu" in Mattannur Municipality for Rs. 0.60 Crore (CAPEX: Rs. 0.56 Crore; O&M: Rs. 0.04 Crore).
- 3. "AMRUT 2.0 -Construction of Park on the bank of KV Canal, Ayyarkulam, Kaniyanthodu, and Vallakadavu" in Vaikom Municipality for Rs. 0.637 Crore (CAPEX: Rs. 0.589 Crore; O&M: Rs. 0.048 Crore)
- ULBs must implement measures to ensure that water bodies remain consistently clean and well-maintained.
- Central Assistance will cover only the Capital Expenditure (CAPEX) and will not extend to Operational & Maintenance (OPEX) costs or land acquisition expenses.
