### ORDER

As per Demand No. XXXV for Other Rural Development Programmes in the State Budget (Demands for Grants and Detailed Budget Estimates 2024-25, Vol III), an amount of Rs. 150 Lakh (Central Share Rs. 75 Lakh and State Share Rs.75 Lakh) has been earmarked under the Head of Account '2515-00-102-32-02 (P) for the Centre for Human Resource Development, KILA (KILA-CHRD) (50% CSS) and an amount of Rs.150 Lakh has been earmarked under the Head of Account 2515-00- 003-44 KILA Centres at Mannuthy, Thaliparamba and Kottarakkara, for the year 2024-25.

2) As per the order read as 2<sup>nd</sup> paper above, Government have accorded sanction for the release of Rs.18,74,665/- (Rs. Eighteen Lakh Seventy Four Thousand Six Hundred and Sixty five Only) under the Head of Account 2515-00-102-32 (Plan) and Rs. 5,00,000/-(Rs.Five Lakhs Only) under the Head of Account 2515-00-003-44(Plan) from the budget allocation for the 2024-25 financial year as the State share equivalent to the Central share available for the KILA CHRD project, to the Central Nodal Agency bank account maintained at Axis Bank Limited holding Account No.922010055736684 operated by the Director General, KILA

3) Principal Director, LSGD as per the letter read as 3<sup>rd</sup> paper above, had reported that due to certain technical reasons the fund could not be transferred into the account of KILA and requested to accord sanction and appropriate orders for the release of Rs.18,74,665/- (Rs. Eighteen Lakh Seventy Four Thousand Six Hundred and Sixty five Only) under the Head of Account 2515-00-102-32-(02) (Plan) and Rs. 5,00,000/-(Rs. Five Lakhs Only) under the Head of Account 2515-00-003-44(Plan) from the budget allocation for the current financial year 2025-26 as the corresponding 50% State share of recurring grant for the Centre for Human Resource Development, KILA, (KILA-CHRD) and KILA Centre at Mannuthy.

4) Government have examined the matter in detail and are pleased to accord sanction for the release of the State Share proportionate to the Central share for the KILA-CHRD Project for the financial year 2024-25, (Rs.18,74,665/- (Rs. Eighteen Lakh Seventy Four Thousand Six Hundred and Sixty five Only) under the Head of Account 2515-00-102-32-(02) (Plan) and Rs. 5,00,000/-(Rs. Five Lakhs Only) under the Head of Account 2515-00-003-44(Plan), that were not transferred to the respective accounts earlier, due to technical reasons.

The ceiling limit for withdrawal of the amount is also raised.
