ORDER

The Ministry of Rural Development (MoRD), Government of India had, vide letter read as 2nd paper above, issued Mother Sanction for a total amount of ₹5,00,00,000/- (General- ₹4,40,25,000/-, SCP- ₹51,60,000/- and TSP- ₹8,15,000/-) as the 1st installment of Central share for the year 2026-27 for the implementation of Mahila Kisan Sashaktikaran Pariyojana - Integrated Farming Cluster (MKSP-IFC) in the State. The Executive Director, Kudumbashree, the implementation agency of MKSP-IFC in Kerala, has informed that the total amount to be released including matching State share of ₹3,33,33,333/- (General- ₹ 2,93,50,000/- SCP- ₹ 34,40,000/- and TSP- ₹ 5,43,333/-) is ₹8,33,33,333/-. Hence, the ED, Kudumbashree has, as per the letter read as 3rd paper above, requested to take necessary action to release the amount.

2. Government have examined the matter in detail. As the balance in the corresponding heads of account (State) is insufficient to release the entire amount to be released, the Government are pleased to accord sanction to release the available amount ie ₹4,03,58,333/- (Rupees Four Crore Three Lakh Fifty Eight Thousand Three Hundred and Thirty Three only) towards the partial release of 1st installment of Central

share and its corresponding State share for the year 2026-27 for the implementation MKSP-IFC in the State, from the current year's budget provision, as shown below;
