ORDER

As per the Government Order read as 2nd paper above, a list of 12 Engineering Colleges was approved to serve as the second tier quality control mechanism envisaged in the works of resilient rebuilding of severely damaged roads as part of Rebuild Kerala Initiative and implemented through the Project Management Unit (PMURKILSGD).

Project Director, Project Management Unit, vide letter read as 3rd paper above, informed that more than 100 works have been mobilised and many of the engineering colleges are heavily overloaded and finding difficulty in rendering their services. On the basis of the willingness expressed by the following four Engineering Colleges, Project Director proposed to include them also in the list of Colleges that serve as second tier quality control mechanism .

1. Govt. Engineering College, Waynad
2. Mar Baselios Institute of Technology & Science, Nellimattom.
3. Providence College of Engg & School of Business, Chengannur
4. Musaliar College of Engineering & Technology, Pathanamthitta

In the case of works of Wayanad district, Project Director reported that due to the difficulties faced in getting quality checks done by the previously assigned College, Project Director executed MoU with the Principal, College of Engineering, Wayanad and engaged GEC as second tier quality check in anticipation of sanction from government . Project Director has requested to ratify this action.

Government have examined the matter in detail and are pleased to accord sanction to include the aforesaid four Engineering Colleges also to serve as the second tier quality control mechanism of works entrusted to PMURKILSGD. These Colleges will serve in compliance with the conditions laid down in the Government Order read as 2nd paper above. Action of Project Director in signing MOU with the Government Engineering College, Wayanad and engaging them for quality control is also hereby ratified.

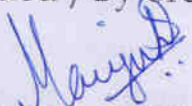
