Local Self Government Department - Setting up of Compressed Bio Gas (CBG) Plant at Kureepuzha, Kollam by M/s Bharath Petroleum Corporation Ltd. (BPCL) - In principle Sanction Accorded - Orders Issued.

ORDER

The Council of Kollam Municipal Corporation as per the Resolution, read as 1st paper above, decided to prepare Survey Plan for establishing CNG / Bio-gas Plant at Kureepuzha, Kollam by Bharath Petroleum

Corporation Ltd. (BPCL) and also to source 120 KLD Bio Waste from the nearby Panchayats and Municipalities in Kollam District, as raw material for the running of the Plant. It was also decided to set apart 7 acres of land to BPCL for establishing CBG Plant.

(2) In the meeting, read as 2nd paper above, it was decided that BPCL shall prepare Detailed Feasibility Report (DFR) for the proposed CBG Plant at Kureepuzha, Kollam. It was also decided that the slurry from the proposed CBG Plant may be processed in the existing STP Plant at Kureepuzha.

(3) In the meeting, read as 3rd paper above, it was decided to examine the feasibility of making the capacity of the CBG Plant as 120 TPD instead of 150 TPD, with the condition that the slurry from the proposed CBG Plant may be processed in the existing STP Plant at Kureepuzha. It was also decided that the Kollam Municipal Corporation shall make available 120-150 TPD waste to the proposed CBG Plant with the assistance of other Local Bodies.

(4) Local Bodies including, Chavara, Neendakara, Thrikkaruva, Perinad, Thrikkovilvattom, Mayyanad, Chathannoor, Panayam, Kottankara, Nedumpana, Thodiyoor Grama Panchayats and Karunagappally, Paravoor, Kottarakkara Municipalities have passed resolutions expressing their willingness to join the Project. A separate agreement has to be executed by the Kollam Corporation with these local bodies to ensure uninterrupted supply of bio-waste to the Plant. As per the reference, read as 4th paper above, Bharat Petroleum Corporation Limited has furnished the Detailed Feasibility Report (DFR) for the purpose.

(5) Government have examined the matter in detail and are pleased to accord in principle sanction for setting up the Compressed Bio Gas (CBG) Plant at Kureeppuzha, Kollam by M/s Bharath Petroleum Corporation Ltd. (BPCL), subject to the execution of the tripartite agreement among the State Government, the BPCL and the Kollam Municipal Corporation, after finalizing the terms with reference to the Detailed Feasibility Report (DFR).
