ORDER

An amount of Rs. 500 lakh has been sanctioned from the Union Government towards the token Mother sanction for the FY 2025-26 in SNA Sparsh module of PFMS under Swachh Bharat Mission (Grameen). The corresponding state share and the corresponding Heads of Accounts are as detailed below :
