## **ORDER**

As per letters read as 1st to 3rd papers above, the Ministry of Rural Development (MoRD) had sanctioned an amount of ₹44,68,00,000/-₹29,61,10,000/-₹10,08,16,828/-, SCPand ₹4,98,73,172/-) as the 2nd tranche of 2nd installment of the Central share for the year 2024-25 for the implementation of NRLM. Being the implementing agency of NRLM in the State, the Executive Director, Kudumbashree, as per letter read as 4th paper above, has informed that the matching State share of the Central release is ₹29,78,66,667/-(General- ₹6,72,11,219/- SCP - ₹19,74,06,667/and TSP -₹3,32,48,781/-), which comes to a total amount of Rs.74,46,66,667/- and requested to release the 2nd tranche of 2nd installment of the Central share and corresponding State share for the implementation of NRLM in the State from the current year budget provision. He has also reported that as per the budget document, the available balance in some of the heads of account are not sufficient to release the full amount. Therefore a

re-appropriation proposal has also been submitted.

2.Government have examined the matter in detail and are pleased to accord sanction to release the available amount of ₹30,55,28,047/-(Rupees Thirty Crore Fifty Five Lakh Twenty Eight Thousand and Forty Seven only) to Kudumbashree as partial release of the 2nd tranche of 2nd installment of Central share and its matching State share for the year 2024-25 for the implementation of NRLM in the State, from the current year's budget provision, as shown below:
