ORDER

As per paper read as 1st above, sanction was accorded for the implementation of the Centrally Sponsored Scheme- Component 1 (City-level action)of the CITIIS 2.0 Program in Thiruvananthapuram City for the object of "Improved & integrated Solid Waste Management in the City of Thiruvananthapuram"and also authorized Smart City Thiruvananthapuram Ltd (SCTL) as the Special Purpose Vehicle (SPV) for an implementation period of four years. As per paper read as 2nd above, permission was accorded for signing the Quadripartite agreement in respect of Component 1 (City Level Action) and Tripartite agreement in respect of Component 2 (State Level Action)of CITIIS 2.0 Program. As per Clause 5 - Financial Commitment of the Quadrilateral Agreement, the tentative total cost of the CITIIS 2.0 project shall be Rs. 154.28 Cr.,but the initial central allocation is limited to Rs. 75 Cr. and according to the financial terms set forth in the said agreement for

Component 1, total disbursement shall be in the ratio 10:40:40:10 against the achievement of dedicated milestones. On signing of the Agreement, 10% of the tentative outlay is entitled as mobilization advance. As per paper read as 3rd above, new head of account with the Principal Secretary/Secretary/Special Secretary- Local Self Government Department (67DL) as the CCO has been opened for classifying the Central Assistance of the project City Investments to Innovate, Integrate and Sustain 2.0.

(2) During the fiscal year 2025-26, budgetary provision of Rs. 4 Lakhs & Rs.1 Lakh has been allocated under the H/A 2217- 05-191-48 (52) City Investments to Innovate, Integrate and Sustain 2.0 (CITIIS 2.0) -Thiruvananthapuram - Central Assistance and H/A 2217- 05-191-48 (53) City Investments to Innovate, Integrate and Sustain 2.0 (CITIIS 2.0)-Thiruvananthapuram - State Share respectively. As per paper read as 4th above, Government of India has accorded sanction for the release of Rs.7.5 Cr. towards the mobilization advance to the Single Nodal Agency (SNA) of the Special Purpose Vehicle (SPV) concerned.

(3) As per paper read as 5th above, sanction was accorded for an additional expenditure to the tune of Rs.7,46,00,000/- (Rupees Seven Crore Forty Six Lakh Only) for the release of the 1st installment of Central assistance towards mobilization advance to Smart City Thiruvananthapuram Limited for the implementation of programmes under component 1 of CITIIS 2.0. As per paper read as 6th above, the Chief Executive Officer, SCTL, has informed that the agreed State Share need to be released only before the completion of the Maturation Phase which stand up to October 2025. Hence the Chief Executive Officer, (CEO) SCTL has requested to release the 1st installment of Central assistance (10% of the tentative outlay) of Rs.7,50,00,000/- (Rupees Seven Crore Fifty lakh) as mobilization advance to the Single Nodal Account (SNA) bearing Account No. 110196064633 opened in the Canara Bank, Cantonment Branch, Thiruvananthapuram (IFSC-CNRB0000819) maintained by Smart City Thiruvananthapuram Limited.

(4) Government have examined the matter in detail and are pleased to accord sanction for the release of the 1st installment of Central assistance (10% of the tentative outlay) of Rs.7,50,00,000/- (Rupees

Seven Crore Fifty lakh) allocated under the H/A 2217- 05 - 191 - 48 (52) City Investments to Innovate, Integrate and Sustain 2.0 (CITIIS 2.0)- Thiruvananthapuram - Central Assistance, as mobilization advance, to the Single Nodal Account (SNA) as detailed above, for the implementation of programmes under Component 1 of CITIIS 2.0.
