ORDER

Government had accorded sanction to partial release of the 2nd tranche of 2nd installment of Central share and its matching State share for the year 2024-25, amounting to ₹30,55,28,047/- to Kudumbashree for the implementation of NRLM, as per the Government order read as 5th paper above. As the available balance in some heads of account was not sufficient to release the entire fund in accordance with the Central sanction, an amount of ₹43,91,40,000/- has been re-appropriated in respective heads of account as per Government order read as 6th paper above.

2. In the above circumstances, Government are pleased to accord sanction to release the balance amount of 2nd tranche of 2nd installment of Central share and its matching State share for the year 2024-25 for the implementation of NRLM in the State, ₹43,91,38,620/- (Rupees Forty

Three Crore Ninety One Lakh Thirty Eight Thousand Six Hundred and Twenty only) to Kudumbashree, from the current year's budget provision, as shown below;
