As per 2nd paper read above, the Government had reconstituted the Governing Body (GB) and Executive Committee (EC) of Vytilla Mobility Hub Society (VMHS).

(2) As per letter read as 3 ^{r d} above, the Managing Director, Vytilla Mobility Hub Society (VHMS) informed that the Ernakulam District Collector was then the Managing Director of VMHS, but later on Ernakulam District Collector has been relieved from the charge of Managing Director, VMHS, hence requested to reconstitute the Governing Body (GB) of the Vytilla Mobility Hub Society VMHS by incorporating the Managing

Director, VMHS and the District Collector, Ernakulam as the 15th & 16th member of Governing Body respectively. The Managing Director, Vytilla Mobility Hub Society (VHMS) has also requested to reconstitute the Executive Committee (EC) of Vytilla Mobility Hub Society (VMHS) by incorporating the Managing Director, VHMS as the Member Secretary and District Collector, Ernakulam, as a member of the Executive Committee (EC) of Vytilla Mobility Hub Society (VMHS). It has also been requested change the designation of the third member of the Governing body from Minister of Public Works and Registration Department to Minister of Public Works Department.

- (3) Government have examined the matter in detail and are pleased to reconstitute the Governing Body (GB) of Vytilla Mobility Hub Society (VMHS) by incorporating the Managing Director, VMHS and District Collector, Ernakulam as the 15th & 16th member of Governing Body (GB) respectively and the Minister for Public Works & Registration Department, assigned as 3^{r d} member in the Governing Body and to change the designation of the third member of the Governing body from Minister of Public Works and Registration Department to Minister of Public Works Department. Government are also pleased to reconstitute the Executive Committee (EC) of Vytilla Mobility Hub Society (VMHS) by incorporating the Managing Director, VHMS in place of District Collector, Ernakulam as the Member Secretary and District Collector, Ernakulam a member of the Executive Committee (EC) of Vytilla Mobility Hub Society (VMHS).
