## **ORDER**

As per the decisions taken during the Fourth National Conference of Chief Secretaries held during 14<sup>th</sup> & 15<sup>th</sup> December 2024, the Logistics Division under the Department for Promotion of Industry and Internal Trade (DPIIT) has requested all States to formulate City Logistics Plans for Tier-2 and Tier-3 cities and further informed that as part of this initiative, 50 cities across India have been identified for the development of City Logistics Plans. Thiruvananthapuram and Kochi have been selected from our State by DPIIT for the purpose. Accordingly, the State is required to prepare City Logistics Plans for these cities, on the basis of master plans/zoning regulations, freight movement, industrial activity, and other logistics considerations.

(2) As an initial step towards this process, the Department for Promotion of Industry and Internal Trade (DPIIT) has requested to provide details of the authority responsible for preparing the City Logistics Plan, in order to facilitate coordination of related activities. As per paper read as 1<sup>st</sup> above, It is proposed that the Directorate of Urban Affairs be designated as the Nodal Agency, and the Director, Urban Affairs, be nominated as the Nodal Officer for coordinating activities related to the City Logistics Plans.

(3) Government have examined the matter in detail and are pleased to designate the Principal Directorate, LSGD as the Nodal Agency and the Director (Urban) LSGD, as the Nodal Officer for co-ordinating activities with respect to the formulation of City Logistics Action Plan for Tier 2 and Tier 3 cities in the State as part of the initiative by the Logistics Division under the Department for Promotion of Industry and Internal Trade (DPIIT), Government of India.
