### ORDER

During the hybrid meeting convened by the Hon'ble Minister for LSGD, Excise & Parliamentary Affairs held on 07.05.2025, it was decided to organize an International Conclave, "Kerala Urban Conclave" 2025. As per paper read as 3<sup>rd</sup> above, Government have accorded sanction for the organization of an International Conclave,"Kerala Urban Conclave" 2025, scheduled to be held on September 12<sup>th</sup> & 13<sup>th</sup> 2025, at Kochi, Ernakulam, to deliberate on the key dimensions of the new policy, based on the recommendations of the Kerala Urban Policy Commission, for shaping sustainable urbanization in the State.

(2) As per the order read as 2<sup>nd</sup> Paper above, Government have accorded sanction for the constitution of various committees (15 Nos) with its respective intent, for the coordination and smooth organization of "Kerala Urban Conclave" 2025, with the composition as detailed therein. As per paper read as 4<sup>th</sup> above, the Principal Director, LSGD has requested to accord administrative sanction for the budget at an estimated amount of Rs.6,50,00,000/- (Rupees Six Crore Fifty Lakhs Only) anticipated for the

conduction of "Kerala Urban Conclave 2025".

(3) Government have examined the matter in detail and are pleased to accord administrative sanction for the budget estimate of Rs.6,50,00,000/- (Rupees Six Crore Fifty Lakhs Only) tentatively required for conducting "Kerala Urban Conclave 2025". The anticipated Budget's cash flow projections from each source and various expenditures pertaining to the proposed Kerala Urban Conclave 2025, appended to this order, are also approved subject to the condition that all procedural and codal formalities as well as financial propriety shall be strictly adhered to in this regard.
