## **ORDER**

As per the Government Order read as the first paper above, a Project Management Unit (PMU) was constituted under the Local Self Government Department as part of the Rebuild Kerala Initiative for the renovation and reconstruction of flood-affected roads and bridges. - CE, LSGD will provide the support of AEEs in Thrissur, Wayanad and Ernakulam if supervision is required.
- Additionally, the AEEs and AEs in PMU will continue to support the PIU teams, especially the works of Thrissur since there is no assigned AE there.
- (4) A period of **two weeks** from the date of this order is granted for the existing PMU to relieve the remaining staff and complete the transfer of files and other formalities.
