### ORDER

Government, as per the order read as 1<sup>st</sup> paper above, have accorded administrative sanction for an amount of Rs. 60 Crores for Extreme Poverty Eradication Programme allocated in the Budget for the Financial Year 2025-26 under the H/A "2515-00-102-25(P)".

2. The Principal Director, Local Self Government Department, as per the letter read as 2<sup>nd</sup> paper above, has requested to modify component-1 in the Administrative Sanction order read as 1<sup>st</sup> paper above as follows, in view of the declaration of Kerala as Extreme Poverty free state on November 1<sup>st</sup>, 2025.

3. The Special Working Group for the Plan Schemes 2025-26 held on 25.10.2025, discussed the matter and as per Minutes read above approved the inclusion of a new component "Announcement of Eradication of Extreme Poverty and IEC Activities" with an outlay of Rs.1.50 crore for the financial year 2025-26, by modifying the outlay of Rs.52.80 crore under the component of "Gap fund to LSGD/LSGI's for Ensuring Safe Shelter for Extreme Poor Families in need of Safe Shelters" to Rs.51.30 crore and permitted to revise the Administrative Sanction issued as per the G.O read as 1<sup>st</sup> paper above accordingly, subject to the condition that the total outlay for the scheme will remain unchanged as Rs.60 crore for the FY 2025-26.

Government have examined the matter in detail and are pleased to modify the Administrative Sanction issued as per Government Order read as 1<sup>st</sup> paper above as detailed in Para 2 above on condition that the total outlay for the scheme will remain unchanged as ₹60 crore for the F.Y.2025-26.
