The Special Working Group for the Plan Schemes 2025-26 held on 25.10.2025, discussed the matter and as per Minutes read above approved the inclusion of a new component "Announcement of Eradication of Extreme Poverty and IEC Activities" with an outlay of Rs.1.50 crore for the financial year 2025-26, by modifying the outlay of Rs.52.80 crore under the component of "Gap fund to LSGD/LSGI's for Ensuring Safe Shelter for Extreme Poor Families in need of Safe Shelters" to Rs.51.30 crore and permitted to revise the Administrative Sanction issued as per the G.O read as 1st paper above accordingly, subject to the condition that the total outlay for the scheme will remain unchanged as Rs.60 crore for the FY 2025-26.
