ORDER

The Ministry of Rural Development, Government of India, as per letter read as 2nd paper above, had sanctioned Mother Sanction for an amount of ₹2.76 Crore towards the 1st installment of Administrative Fund as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) under SNA SPARSH for the year 2025-26. Accordingly the Chief Engineer, KSRRDA, as per letter read as 3rd paper above, has reported that the corresponding State share of the Mother Sanction amount is ₹1.84 Crores. As the budget provision for 2025-26 is insufficient to release the Mother sanction amount along with its corresponding state share, the Chief Engineer,KSRRDA has requested to release a total amount of ₹4,60,00,000/-(Central Share and State Share) as the first installment of the Administrative Fund after additional authorization of fund to State's Budget Head 4515-00-800-98 (2) State.

2. Government have examined the matter in detail. As per Government Order read as 4th paper above, authorization of additional expenditure has been sanctioned to the Head of account concerned. In the Circumstance, Government are pleased to accord sanction to release an amount of ₹4,60,00,000/-(Rupees Four Crore Sixty Lakh Only) as the first installment of the Administrative Fund under SNA SPARSH for the

implementation of PMGSY during the Financial Year 2025-26 from the head of account 4515-00-800-98 (2) State, towards the aforesaid Mother Sanction from the current Year's budget provision, as detailed below, subject to the Conditions stipulated in the Circular read as 1st paper above.
