### ORDER

Sri.Shabeer Thalappadi Abbas was awarded with a contract by the Secretary, Mangalpady Grama Panchayat for the removal of accumulated municipal solid waste from the Kubanoor Waste Treatment Plant. The petitioner claimed that he removed and transported the waste to Mangaluru as per the work order dated 16.08.2021. A part payment of Rs.15,00,000/- was made on 03.01.2022. Alleging non payment of balance contractual dues of Rs.81,98,110/- the petitioner filed WP(C) 33793/2025 seeking directions from the Hon'ble Court to consider the pending representations and release the balance dues without further delay.

(2) The Hon'ble High Court as per the judgment, read as 1<sup>st</sup> paper above, disposed of the WP(C) by directing the 1<sup>st</sup> (Secretary, LSGD) and 2<sup>nd</sup> respondent (Director, LSGD Rural) to take up Exts.P12 and P13 (representations submitted by the Petitioner) respectively and appropriate decisions thereon shall be taken within a period of two months from the

date of receipt of a copy of the judgment, after giving the petitioner an opportunity of being heard.

(3) The petitioner was heard by the 1<sup>st</sup> respondent on 23.10.2025. Based on the hearing the petitioner was directed to submit documents / proof showing the quantity of waste removed, transported or processed.

(4) As per the communication read as 3<sup>rd</sup> paper above, the Counsel for the petitioner submitted copy of documents like service charge receipts issued by White Rose Distributors and Weightment Certificates issued by Kesoram Industries Ltd. (Birla Shakti Cement) and photographs of the site before and after mining. It is reported that the records collectively show the quantity of solid waste transported for disposal, the corresponding service charge paid and the verification of actual weight.

(5) Since the authenticity of the above documents need to be ascertained, Government are pleased to constitute a Committee with the following members for verifying the authenticity of documents in the Annexure to this order.
