ORDER

As per paper read as 1st above, Government has accorded sanction for the release of the 1st installment of Central assistance (10% of the tentative outlay) of Rs.7,50,00,000/- (Rupees Seven Crore Fifty lakh) allocated under the H/A 2217- 05 - 191 - 48 (52) City Investments to Innovate, Integrate and Sustain 2.0 (CITIIS 2.0)- Thiruvananthapuram - Central Assistance, as mobilization advance, to the Single Nodal Account (SNA) for the implementation of programmes under Component 1 of CITIIS 2.0. Now the Scheme CITIIS 2.0 (City Investment To Innovate Integrate and Sustain 2.0) has been notified for implementation under SNA SPARSH through RBI e-KUBER payment platform of the RBI.

(2) The Chief Executive Officer (CEO), Smart City Thiruvananthapuram Limited (SCTL) as per paper read 2nd above, informed that since the period up to October 2025 comes under Maturation Phase of CITIIS 2.0 during which no implementation was allowed as per the Ministry of Housing & Urban Affairs (MoHUA) guidelines. Therefore Smart City Thiruvananthapuram Limited (SCTL) incur any expenditure against the 10% released as mobilization advance. As a step for on boarding the scheme to SNA SPARSH, SCTL has requested to refund the unspent balance of Rs. 7.50 Cr in SNA to the Consolidated Fund of India.

(3) Government have examined the matter in detail and are pleased to accord sanction to the Chief Executive Officer (CEO), Smart City Thiruvananthapuram Limited (SCTL) for remitting the unspent balance of Rs. 7.50 Cr. released towards central share under the H/A 2217- 05 - 191 - 48
