ORDER

As per the Government order read as 1st paper above, Administrative Sanction was accorded for an amount of ₹ 3,79,17,241/- (Three Crore Seventy Nine lakh Seventeen Thousand Two Hundred and Forty One) for the construction of a LIFE Apartment (Housing Complex) comprising 24 units in the land donated by Shri Shameer Pookkuzhi at Nellikuzhy Grama Panchayat,Ernakulam District. An agreement was executed between the Secretary, Nellikuzhy Grama Panchayat and LIFE Mission on 07.10.2023, as per which an amount of ₹379.17 lakh is to be released by LIFE Mission to Nellikuzhy Grama Panchayat in five instalments, for the construction of apartments, based on the progress of work. The first installment of ₹75,39,962/- was sanctioned as per the orders read as 2nd and 3rd papers

above.

2) The Chief Executive Officer, LIFE Mission, as per the letter read as 4th paper above, has requested to release the second installment of Rs.80 lakhs (Rupees Eighty lakhs only) from head of account '4515- 00-102-49 (P) of LIFE Mission to the PSTSB Account of the Secretary, Nellikuzhy, Grama Panchayat (PSTSB Account number :799012700002772) at Sub Treasury, Kothamangalam).

3) Government have examined the matter in detail and are pleased to release an amount of Rs 80,00,000 (Rupees Eighty lakhs only) from the Head of account '4515-00-102-49(P) of LIFE Mission to the Secretary, Nellikuzhy, Grama Panchayat and credited to PSTSB A/c No. 799012700002772 at Sub Treasury, Kothamangalam as second installment towards the construction of LIFE apartments under the partnership project at Nellikuzhy Grama Panchayath also by enhancing the ceiling limit for the purpose.
