### ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2<sup>nd</sup> paper above, had sanctioned a total amount of ₹1,95,00,000/ (General- ₹1,71,70,000/-, SCP- ₹ 20,13,000/- and TSP- ₹ 3,17,000/-) as the 2<sup>nd</sup> tranche of 1<sup>st</sup> installment of Mother Sanctioned Fund of Central share under SNA SPARSH for the year 2025-26 for the implementation of Mahila Kisan Sashaktikaran Pariyojana - Integrated Farming Cluster (MKSP-IFC). The Executive Director of the implementing agency of MKSP-IFC in Kerala, Kudumbashree, as per the letter read as 3<sup>rd</sup> paper above, has reported that a total amount of ₹3,25,00,000 /- is needed to release the aforesaid Central share along with its matching State share of ₹1,30,00,000 /-(General - ₹1,14,46,667 /-, SCP - ₹13,42,000 /- and TSP - ₹2,11,333 /-). But the balance available in the corresponding heads of accounts is only ₹1,95,01,000/-. Hence, the ED, Kudumbashree has requested to release the available amount and also requested to take necessary steps to re-appropriate

from sufficient heads to meet the balance requirement ₹1,29,99,000/-.

2. Government have examined the matter in detail. As the balance in corresponding heads of accounts is insufficient to release the entire amount to be released, the Government are pleased to accord sanction to release the available amount ie, ₹1,95,01,000/- (Rupees One Crore Ninety Five Lakh and One Thousand only) towards the partial release of Central release and its corresponding State share for the year 2025-26 for the implementation MKSP-IFC in the State from the current year's budget provision, as shown below, subject to the conditions stipulated in the Circular read as 1<sup>st</sup> paper above.
