### ORDER

The Ministry of Rural Development, Government of India, as per the letter read as 1<sup>st</sup> paper above, has sanctioned and released an amount of ₹24,30,099/- (Rupees Twenty Four Lakh Thirty Thousand and Ninety Nine Only) as the 1<sup>st</sup> tranche of the 1<sup>st</sup> installment of the Central Grant for recurring expenditure for the financial year 2025-26 to KILA CHRD (₹19,79,299/-) and ETC Mannuthy (₹4,50,800/-).

(2) As per Demand No. XXXV for Other Rural Development Programmes in the State Budget (Demands for Grants and Detailed Budget Estimates 2025-26, Vol III), an amount of ₹150 Lakh (Central Share Rs. 75 Lakh and State Share Rs. 75 Lakh) has been earmarked under the Head of Account "2515-00-102-32 (P) for the Centre for Human Resource Development, KILA (KILA-CHRD) (50% CSS)" for the year 2025-26.

(3) The Principal Director, LSGD as per the letter read as 2<sup>nd</sup> paper above, has forwarded a proposal requesting sanction for the release of Rs.24,30,099/- (Rupees Twenty Four Lakh Thirty Thousand and Ninety Nine Only), from the Head of Account 2515-00-102-32 (02) (Plan) from the budget allocation for the current financial year 2025-26; as the

corresponding state share (50%) of the funds received from the Ministry of Rural Development, Government of India.

(4) Government have examined the matter in detail. There is a scheme "Strengthening of KILA Centres at Mannuthy, Thalipparamba and Kottarakkara" in the plan 2025-26 (2515-00-003-44 PV) and ₹1.5 crore is earmarked. But the same is merely a State Scheme.

(5) As per the plan write-up, the State share for "Management Support to Rural Development Programmes and Strengthening District Planning Process etc" is included under the State Scheme 'Centre for Human Resource Development (KILA-CHRD-erstwhile SIRD)(50% State Share).

(6) In the circumstances stated above, sanction is accorded for the release the State share of ₹19,79,299/- (towards SIRD, Kerala) and ₹4,50,800/- (towards ETC, Mannuthy) (Total ₹24,30,099/-) against the Central Share received, from the available provision under the Head of Account 2515-00-102-32-02-KILA-CHRD-State Share PV.
