ORDER

The Ministry of Rural Development (MoRD), GoI, had, as per the letter read as 2nd paper above, issued Mother Sanction for ₹13,95,00,000/- (General - ₹9,87,80,000/-, SCP - ₹2,54,17,000/- and TSP ₹1,53,03,000/-), towards 1st tranche of 1st installment of Central share during the year 2025-2026 for the implementation of DDUGKY in the State. The total amount to be released is ₹23,25,00,000/- including matching State share of ₹9,30,00,000/- (General - ₹6,58,53,333/-, SCP - ₹1,69,44,667/-, TSP - ₹1,02,02,000/-). The Executive Director, Kudumbashree has, as per the letter read as 3rd paper above, reported that the current year budget provision under the correspondent State share Heads is only ₹9,30,00,000/-. Hence, the ED, Kudumbashree has requested to release available amount of ₹9,30,00,000/-.

2. Government have examined the matter and are pleased to accord sanction to release an amount of ₹9,30,00,000/- (Rupees Nine Crore and Thirty Lakh only) as partial release of 1st tranche of 1st installment of Central share along with corresponding State share under SNA SPARSH

for the FY 2025-26 for the implementation of DDU-GKY in the State as shown in the table below, subject to the conditions stipulated in the Circular read as 1st paper above;
