Out of the total amount ₹3,25,00,000/- to be released towards the Mother Sanctioned fund ₹1,95,00,000/- allotted by MoRD, GoI as the 2nd tranche of 1st installment of Central share for the year 2025-26 for the implementation of MKSP-IFC in the State and its corresponding State share ₹1,30,00,000/-, sanction had been issued to release the then available amount ₹1,95,01,000/-, as per GO read as 4th paper above. Now, as per GO read as 5th paper above, an amount of ₹1,30,00,000/- has been reappropriated to the the corresponding heads of accounts to enable the release of the balance amount ₹1,29,99,000/-.

2) In the above circumstances, Government are pleased to accord sanction to release an amount of ₹1,29,99,000/- (Rupees One Crore Twenty Nine Lakh and Ninety Nine Thousand only) towards the balance amount of 2nd tranche of 1st instalment of Central share along
