ORDER

As per the Order read as 1st paper above, Government accorded administrative sanction for an amount of Rs.14.50 crore under the head of account '2515-00-102-21-36 (P) General- Non salary' of KSLMA, and as per the Order read as 2nd paper above, Rs.7,32,09,280/- was sanctioned from above head of account for disbursing the honorarium arrears to the Saksharatha Preraks, upto May 2025. As per the order read as 4th paper above, Government have accorded administrative sanction for increasing prerak honorarium by Rs.1000/- per month. Subsequently, as per the order read as 5th paper above, Rs.4,33,42,000/- was sanctioned from the head of account '2515-00-102-21-36 (P) General- Non salary' towards arrears of Prerak honorarium for the period from June 2025 to November 2025. Now, as per the letter read above as 6th paper,

the Director, KSLMA has forwarded a proposal for sanctioning an amount of Rs.3,08,08,000/- towards the arrears of Prerak honorarium for the period from December,2025 to March 2026 from the head of account '2515-00-102-21-36 (P) General- Non salary'.

2. Government have examined the proposal in detail and are pleased to accord sanction for the release of an amount of Rs.2,00,00,000/- (Rupees Two crore only) from the head of account '2515-00-102-21-36 (P)' General-Non Salary, during 2025-26, towards the arrears of Prerak honorarium for the period from December,2025 to March 2026. The sealing limit has been increased to 97.62% for this purpose.
