### ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2<sup>nd</sup> paper above, sanctioned a total amount of ₹9,87,10,000/- as the 2<sup>nd</sup> tranche of 1<sup>st</sup> instalment of Central share Mother Sanction under SNA SPARSH for the year 2025-26 for the implementation of SVEP umbrella projects in the State. As per GO read as 3<sup>rd</sup> paper above, sanction to release an amount of ₹13,54,83,333/- had been accorded towards partial release of Central Share along with the corresponding State Share, from the available balance in Budget heads. As per GO read as 4th paper above, an additional authorization of ₹ 2,90,34,000/- had been sanctioned to enable the release of the balance amount ₹2,90,33,334/-. The Executive Director, Kudumbashree, as per the letter read as 5th paper above, has requested to release the balance amount.

2. Government have examined the matter and are pleased to accord sanction to release an amount of ₹2,90,33,334/- (Rupees Two Crore Ninety Lakh Thirty Three Thousand Three Hundred and Thirty Four only) towards

the balance amount of 2<sup>nd</sup> tranche of 1<sup>st</sup> instalment of Central share along with corresponding State share for the FY 2025-26 for the implementation of SVEP umbrella projects in the State from the current year's budget provision by debiting the head of account 2501-06-198-48-16, subject to the conditions stipulated in the Circular read as 1<sup>st</sup> paper above.

3. The guidelines and procedures stipulated in the Circular read as 1<sup>st</sup> paper above and the conditions stipulated in the letter read as 2<sup>nd</sup> paper above should strictly be followed and complied with. The controlling officer concerned will take timely steps to regularise the additional authorization as per GO read as 4th paper above through Re-appropriation of Savings only within the Grant before the close of the current financial year.
