ORDER

The Hon'ble Kerala Administrative Tribunal, Ernakulam, vide the 2nd paper read above, disposed of OA(EKM) No. 798/2025 filed by Smt. Sindhu N, Assistant Executive Engineer, with the following direction:

"The applicant was transferred out of Kozhikode based on the recommendation of V&ACB in the light of a Vigilance Case registered against her. The affidavit filed by the Investigating Officer would show that the investigation in the Vigilance Case is complete. The only reason for transferring the applicant out of Kozhikode is the recommendation by the V&ACB. In the light of the subsequent developments, there appears no reason to keep her out of Kozhikode, especially in the light of the personal difficulties cited by her.

Accordingly, the Original Application is disposed of with a direction to the 1st respondent to consider the prayer of the applicant to grant her a transfer back to Kozhikode considering the present stage of investigation of the V&ACB. Final orders in this regard shall be issued within two months from the date of receipt of a copy of this order."

Though the applicant was transferred vide the 1st paper read above based on the recommendation of the Vigilance and Anti-Corruption Bureau, Government have subsequently been informed that no evidence was revealed during investigation to establish that the accused, including Smt. Sindhu N, had accepted any bribe from the complainant, caused any pecuniary gain to any person, or participated in any criminal conspiracy, and hence successful prosecution is not feasible. It has further been reported that a Further Action Dropped (FAD) final report in the case was filed on 27.11.2025 before the Enquiry Commissioner and Special Judge, Kozhikode, and the Hon'ble Court has not yet taken a final decision in the matter.

Government have examined the matter in detail and, in the above circumstances, are pleased to post Smt. Sindhu N, Assistant Executive Engineer (PEN: 440070), against the existing vacancy in Kozhikode Corporation. Accordingly, the order of the Hon'ble Kerala Administrative Tribunal, Ernakulam, in OA(EKM) No. 798/2025 vide the 2nd paper read above stands complied with.
