ORDER

The Ministry of Rural Development (MoRD), Government of India had, vide letter read 2nd paper above, issued Mother Sanction for the release of ₹9,10,00,000/- towards the Central share for the year 2026-27 for the implementation of Start-up Village Entrepreneurship Programme (SVEP) in the State. The Executive Director, Kudumbashree, the implementation agency of SVEP in Kerala has, as per the letter read as 3rd paper above, informed that the total amount to be released including matching State share ₹6,06,66,667/- is ₹15,16,66,667/-. and requested to take necessary action to release the same.

2. Government have examined the matter in detail. The total budget provision under the corresponding head of account (State share) is ₹15 crore only. Hence the Government are pleased to accord sanction to release an amount of ₹15,00,00,000/- (Rupees Fifteen Crore only) towards the partial release of 1st installment of Central share along with its corresponding State share for the FY 2026-26 for the implementation of SVEP umbrella projects in the State from the current year's budget

provision by debiting the head of account 2501-06-198-48-16.

3. The guidelines, conditions and procedures stipulated in the Circular read as Ist paper above and the Sanction order read as 2nd paper above should strictly be followed and complied with.
