### ORDER

As per the letter read as 1<sup>st</sup> paper above, the Ministry of Housing and Urban Affairs, Govt. of India has conveyed Mother Sanction for an amount of Rs.54,90,000/- (Rupees Fifty Four Lakh Ninety Thousand only) to Government of Kerala for Information, Education and Communication (IEC) component under AMRUT 2.0, through SNA SPARSH platform.

2. As per the letter read as 2<sup>nd</sup> paper above, the Mission Director AMRUT has requested for additional authorization and to accord sanction for the release the fund under the following Budget Heads, to receive Central Government Assistance (DDO CODE: 010467D053), as detailed below;

The Mission Director AMRUT has further reported that due to the delay in the release of funds, the required amount was drawn from the AMRUT Reform Incentive Fund, and the same may now be recouped and credited back to the account from which it was utilized.

As per G.O. read as 3<sup>rd</sup> paper above, additional expenditure to the tune of Rs.54,91,000/- (Rupees Fifty Four Lakh Ninety One Thousand Only) has been authorized to provide funds against the mother sanction sanctioned for information, Education and Communication (IEC) component under AMRUT 2.0 as 1<sup>st</sup> installment for year 2026-27 in accordance with the fund flow mechanism devised for SNA SPARSH so as to release the Central share .
