ORDER

As per the letter read as 1st paper above, The Ministry of Housing & Urban Affairs has conveyed the mother sanction for an amount of Rs.2,67,80,000/-(Rupees Two Crore Sixty Seven Lakhs Eighty Thousand Only) towards Administrative and Other Expense (A&OE) component of AMRUT2.0, through SNA SPARSH platform.

2. As per the letter read as 2nd paper above, the Mission Director AMRUT has reported that the budget provision under respective Heads of account for the FY 2026-27, is ₹0.01 crore, and requested for Additional Authorization and release of an amount of Rs.2,67,80,000/-(Rupees Two Crore Sixty Seven Lakhs Eighty Thousand Only) under the Budget Heads, to enable receipt of Central Government Assistance (DDO Code: 010467D053), as detailed below;

The Mission Director, AMRUT has also requested to accord sanction for the transfer credit of the amount to the Account of AMRUT 2.0 maintained by the Mission Director AMRUT with Account Number 7727206279 in Indian Bank, Thycaud Branch (IFS Code: IDIB000T021). Mission Director, AMRUT has also reported that due to the delay in release of fund, the same amount was utilized from AMRUT reform incentive fund and in the above circumstance, the amount may be recouped the same and transferred credit to the utilized account.

As per the GO read as 3rd paper above, additional expenditure to the tune of Rs.2,65,81,000/- (Rupees Two Crore Sixty Five Lakh Eighty One Thousand Only) has been sanctioned for utilization of the Central Assistance received in accordance with the SNA-SPARSH fund flow mechanism for the Administrative and Other Expenses (A&OE) component under AMRUT 2.0.

Government have examined the matter and are pleased to accord sanction for the release of an amount of Rs.2,67,80,000/- (Rupees Two Crore Sixty Seven Lakhs Eighty Thousand Only) towards A&OE (Administrative and Other Expense) component of AMRUT 2.0 as detailed below and allocate the amount to the Mission Director AMRUT (DDO CODE: 010467D053).
