Abstract.- Scales of Pay Chief Executives of the State Public Sector Undertakings -
Revised –Orders issued

ORDER

The following are the existing scales of pay of the Chief Executives of the State Public Sector Undertakings.

2. The Central Bureau of Public Enterprises has now declared ad hoc relief to those Board Level Officers who are in the Central Schedule, with effect from 1st January 1986 as detailed below:-

3. Government have considered the guidelines of the Central Bureau of Public Enterprises in this behalf. As the State Schedules A, B, and C were in conformity with Central Schedules B, C and D were paid Central Undertakings D.A., Government are pleased to order that those officers in these schedule in the State Public Sector Undertakings will be allowed the same ad hoc relief as was paid by Government of India.

4. The Schedules D,E and F were not connected with Central Schedules and these Schedules carried State D.A. which was more than the Central Undertakings D.A. Therefore ad hoc relief declared by Government of India cannot be paid in those cases. Government of India cannot be paid in those cases. Government therefore order that these scales be revised on the lines of the revision given for the State Government Employees by merging D.A. at 488 points with the pay. Accordingly the Schedules D, E and F are revised as follows:-

5. On the basis of the above, the following will be the new Schedules for the Chief Executives.

The ad hoc relief/ revision will take effect from 1st October 1987.

6. The fixation of pay in the revised scales of pay will be done as provided in the Government Pay Revision Orders. As regards the H.R.A, the Chief Executives are entitled to residential accommodation. The maximum of this will continue to be 10 per cent. In respect of those who occupy their own house, H.R.A will continue to be paid at the existing rates/at the new State Government rates. In respect of Schedules A to C, the ad hoc relief also will be treated as pay for the purpose of calculation of residence facility.
