ORDER

1. Sanction was accorded as per the Government order cited as 1st paper above for approaching the Kerala State Industrial Development Corporation (KSIDC) for undertaking notification of the tender for infrastructural services for Local Body Computerisation with Private Public Partnership and to complete the various stages from tender till the process of the award. Sanction was also given to meet the consultancy charges for the services rendered by Kerala State Industrial Development Corporation (KSIDC) from the Additional Central Assistance sanctioned to Information Kerala Mission for the activities of computerisation of three tier Panchayats.

2. As per the reference 3 cited above the General Manager, Kerala State Industrial Development Corporation (KSIDC) had agreed to undertake the assignment, but with the active assistance of a hired external consultant. The details of operationalising the selection of the consultant and execution of the BOLT tendering arrived at through consultations of Kerala State Industrial Development Corporation (KSIDC) and Local Self Government Department has been outlined in the minutes of the meeting cited as reference (4) above. The Seventh Implementation Committee of Information Kerala Mission held on 27/10/2003 has approved the revised version of the Request for Proposal (Fifth version: October 2003) for the tender process which has been cited as reference (5) above. The Executive Mission Director, Information Kerala Mission has vide reference (2) cited above proposed that orders may be issued authorising Kerala State Industrial Development Corporation (KSIDC) to hire the services of an external technical consultant to undertake execution of the bid process.

The Government have examined the proposal in detail and are pleased to accord sanction to Kerala Industrial Development Corporation to hire an external consultant to initiate the tender process for providing Infrastructural services to the Local Self Government Institutions through Public Private Partnership in a time bound manner.

3. Sanction is accorded to Kerala State Industrial Development Corporation (KSIDC) to undertake the bid management of the BOLT tender based on the fifth version of Request for Proposal (October 2003) subject to the condition that any deviation in tender conditions from the RFP shall have the specific sanction of the Local Self Government Department.

4. Sanction is also accorded to the Managing Director, Kerala State Industrial Development Corporation (KSIDC) to constitute a committee consisting of the following to finalise the hiring of the consultant and their recommendations on the BOLT tender.

- (1) Principal Secretary, Finance Department
- (2) Secretary, Information Technology Department
- (3) Secretary, Local Self Government Department
- (4) Managing Director, Kerala State Industrial Development Corporation (KSIDC)

The Committee shall be empowered to invite subject experts to its meetings as and when necessary.

5. Sanction is also accorded to the Local Self Government Department for meeting the actual expenses for tender notification, pre-bid conference, tender processing consultancy charges for the hired actual consultants any other expenses incurred in this process of

tendering and also the Kerala State Industrial Development Corporation's (KSIDC's) fee for bid management from the Additional Central Assistance of Information Kerala Mission.


