ORDER

Smt.K.V.Vanaja, Casual Sweeper, Block Development Office, Mananthavady who has been working since 02.05.1997 submitted a representation before the Government as per 4th paper read above, requesting to regularize her service as Part Time Sweeper as per 1st paper above.

As the representation is under consideration of the Government, she has filed O.A.(EKM)398/15 before the Hon'ble Kerala Administrative Tribunal with the same request. The Hon'ble Administrative Tribunal in its Order read as 5th paper above directed the first Respondent, ie, Secretary, Local Self Government Department to pass orders on the claim of the applicant for regularization within three months from the date of receipt of a copy of this order.

As per the letter read as 6th paper above, the Commissioner for Rural Development has forwarded proposals for creation of a post of Part Time Sweeper in the Block Development Office, Mananthavady and for regularization of the service of Smt.K.V.Vanaja to that post. He has reported that Smt.K.V.Vanaja is working as Casual Sweeper on daily wages at Block Development Office, Mananthavady since 02.05.1997. As per the Sweeping Area Certificate issued by the Assistant Engineer, PWD Building Division, Mananthavady, the sweeping area of Block Development Office, Mananthavady

is 1013.01 Sq.Ms. At present there is a Part Time Sweeper on regular basis in that office.

Government have examined the matter in detail. As per the G.O read as 1st paper read above, the Part Time Sweeper post shall be created w.e.f. the date of appointment of the incumbent as Casual Sweeper or from 18.06.2001. Further as per the G.O read as 2nd paper above orders were issued for regularization of existing Casual Sweepers, irrespective of their mode of appointment, based on the Sweeping area as defined in the Government Order read as first paper above with effect from the date of that order (09.02.2010). In the instant case as the sweeping area is 1013.01 m² and the proposal is in consistent with the guidelines in the G.O read as 1st paper above, Government are pleased to accord sanction to create a post of Part Time Sweeper in the Block Development Office, Mananthavady in addition to the existing one and to regularize the service of Smt.K.V.Vanaja in that post w.e.f. the date of Order. Thereby the direction contained in the Order of the Hon'ble Kerala Administrative Tribunal in O.A.(EKM)398/15 is complied with.

The Commissioner for Rural Development is directed to fill up the vacancy arising out of the retirement of Smt.Vanaja, through Employment Exchange only.
