ORDER

Indian Oil -Adani Gas Private Limited (IOAGPL) is a 50:50 Joint Venture Company of Indian Oil Corporation Limited (IOC)- a Maharatna Company of Government of India and Adani Gas Limited(AGL), a 100% Adani Group Company set up to implement City Gas Distribution (CGD) projects in various cities of the Country. This Joint Venture has been awarded "Authorisation by the Petroleum & Natural Gas Regulatory Board (PNGRB),Government of India for the implementation of city Gas Distribution Project in Ernakulam District. The project would cover 3054 sq. kms of Kochi town and adjoining areas.

2. Indian oil -Adani Gas Private Limited has requested the State Government to extend all possible support for the project and to direct the local bodies/authorities in expediting the grant of necessary permissions. The project involves laying of underground Steel and MDPE pipeline Network across the city to supply environment friendly fuel (Natural Gas) to the customers in domestic,commercial, industrial and transport sectors. The concept of the project is to distribute Natural Gas to households, hotels,restaurants ,hospitals at prices cheaper than LPG. The operator company will require pipeline laying permission from Government

Departments like PWD, National Highway Authority, Inland Water Authority and other agencies like Kochi Corporation, Municipalities and Grama Panchayats.

3. In the above circumstances Government are pleased to direct to Local Self Government Institutions to give all possible assistance to Indian Oil -Adani Gas Private Limited for the successful implementation of the Project "City Gas Distribution". Any delay in granting permission for road cutting etc will be viewed very seriously. The Heads of Departments will issue necessary instructions to the officers under their control.
