As proposed by **Sri.K.Kunhiraman, MLA, Thrikkariapur Constituency** under LAC-ADS read as 4th paper above, the Chief Engineer, PWD, Roads and Bridges, Thiruvananthapuram has furnished detailed estimate for the work 'Improvements to Kakkadavu - Bedoor - Kamballur road km 3/200 to 4/800' at an estimate cost of Rs.30,00,000/- (Rupees Thirty lac only) read as 3rd paper above to accord Administrative Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Improvements to Kakkadavu - Bedoor- Kamballur road km 3/200 to 4/800 proposed under LAC-ADS of **Sri.K.Kunhiraman, MLA representing Thrikkariapur Constituency** at an estimate cost of Rs.30,00,000/- (Rupees Thirty lac only) with special sanction to take up the work for execution, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government Orders subject to the condition that the work should be executed as deposit work through PWD and the Chief Engineer, Local Self Government Department should take necessary steps to deposit the required amount to PWD, as stipulated in the circular read as 2nd paper above.


