As proposed by Sri.K.Kunhiraman, MLA, Thrikkariapur Constituency under LAC-ADS read as 3<sup>rd</sup> paper above, the Chief Engineer PWD, Roads and Bridges, Thiruvananthapuram has furnished detailed estimate of the work '**Improvements to Veethu Kunne-ring road ch.km-0/00 to 0/650 in Pilicode Grama Panchayath**' at an estimate cost of ₹.25,00,000/- (Rupees Twenty Five lac only) read as 4<sup>th</sup> paper above to accord Administrative Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work '**Improvements to Veethu Kunne-ring road ch.km-0/00 to 0/650 in Pilicode Grama Panchayath**' proposed under LAC-ADS of Sri.K.Kunhiraman, MLA representing Thrikkariapur Constituency at an estimate cost of ₹.25,00,000/- (Rupees Twenty lac only) with special sanction to take up the work for execution as deposit work through PWD subject to resolution passed by the Local Body concerned in this regard, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1<sup>st</sup> paper above and subsequent Government Orders .
