2. In the letter read as 8th paper above Commissioner for Rural Development informed that final list of SECC was sent to Ministry of Rural Development for publication . But a resurvey on the Manuel scavengers & sanitary latrine based on the socio economic caste census is inevitable hence the service of Sri .S .Manu, Additional District Officer (Rtd.) is needed in the SECC Cell,. Hence requested for permission to extend the service of Sri.S. Manu, Additional District Officer (Rtd.) on contract basis for a period of three months in the SECC cell

from 1st August , 2015 to 31st October 2015.

3. Government have examined the case in details and are pleased to extend the service of Sri.S.Manu, Additional District Officer (Rtd.) in SECC Cell on contract basis for a further period of three months w.e. .from 1st August , 2015 to 31st October 2015.

4. Sanction is also accorded to meet the expenditure in this regard from the SECC fund of Commissioner for Rural Development.


