As proposed by Sri.C.Mammutty, MLA Tirur Constituency under LAC-ADS read as 3rd paper above, the Chief Engineer, PWD, Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work 'Improvements to Chandanakkavu-Melapathur Kshethram -Illaparamba Road in Athavanad Grama Panchayath' at an estimate cost of ₹.25,00,000/- (Rupees Twenty Five lac only) read as 4th paper above to accord Administrative sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work "Improvements to Chandanakkavu-Melapathur Kshethram -Illaparamba Road in Athavanad Grama Panchayath' proposed under LAC-ADS 2015-16 of Sri.C.Mammutty. 
