ORDER

As proposed by **Adv.Jose Thettayil, MLA** representing Angamaly Constituency under LAC- ADS , the Senior Manager, KELTRON has furnished detailed estimate of the work Installation of High Mast Lighting Systems at 7 places (6 Grama panchayats and 1 Municipality) in Angamaly Constituency at an estimate cost of ₹.42,28,500/- (Rupees Forty Two Lac Twenty Eight Thousand and Five Hundred Only) as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction. The respective Local bodies passed and forwarded necessary resolution in this regard.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work, Supply, Installation and Commissioning of 7 High Mast Lighting Systems in 6 Grama Panchayaths and 1 Municipality in Angamaly Constituency under LAC-ADS of **Adv.Jose Thettayil, MLA** representing Angamaly Constituency, as detailed below, at a total estimate cost of ₹.42,28,500/- (Rupees Forty Two Lac Twenty Eight Thousand and Five Hundred Only) with special sanction to take up the work for execution, as deposit work through KELTRON, Thiruvananthapuram following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government Orders. The Chief Engineer Local Self Government Department should take necessary action to deposit the required amount to KELTRON, Thiruvananthapuram, the executing agency, as envisaged in the circular read above.


