As proposed by Sri.Hibi Eden, MLA representing Ernakulam Constituency under LAC-ADS for the year 2015-16, the Chief Engineer, PWD, Buildings, Thiruvananthapuram has furnished detailed estimate of the work Construction of First & Second Floors to Cheranalloor Grama Panchayath Building at an estimate cost of Rs.50,00,000/- (Rupees Fifty Lac only) as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Construction of First & Second Floors to Cheranalloor Grama Panchayath Building under LAC-ADS of Sri.Hibi Eden, MLA representing Ernakulam Constituency for the year 2015-16 at an estimate cost of Rs.50,00,000/- (Rupees Fifty Lac only) with Special Sanction to take up the work for execution as deposit work through PWD subject to the resolution passed by the concerned Local Body in this regard, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders. 
