As proposed by Dr.N.Jayaraj, MLA representing Kanjirappally Constituency as per the letter read as 3rd paper above, the Assistant Executive Engineer, PWD Roads Sub Division, Changanacherry has furnished detailed estimate of the work Improvements to Palamattom - Koothrapally - Mampathy - Santhipuram Road Ch.1/000to 5/400 (Kooramattom -Thakadiyel) in Karukachal Grama Panchayat under LAC-ADS for the year 2015-16 at an estimate cost of Rs.50,00,000/- (Rupees Fifty Lac only) as per the reference read as 4th paper above to accord Administrative Sanction.


