ORDER

The Chief Engineer, Kerala State Rural Roads Development Agency, LSGD as per the letter read as 1st paper above has submitted a proposal for allotting an additional amount of Rs. 94,51,140/- required to complete the work Madalam-Pothukundu Road included in Phase VIII- Batch 1, Package No. KR-04-51, Thaliparamaba Block, Kannur, amounting to Rs. 2,81,90,682/- against the sanctioned estimate PAC of Rs. 1,87,39,542/-. The Revised estimate amount incorporating all deviations comes to Rs. 2,81,90,682/- (Rupees two crores eighty one lakhs ninety thousand six hundred and eighty two only) against the original estimate for Rs. 1,87,39,542/- (Rupees one crore eighty seven lakhs thirty nine thousand five hundred and forty two only).

2) Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the completion of the work Madalam-Pothukundu Road included in Phase VIII- Batch1, Package No. KR-04-51, Thaliparamaba Block, Kannur for an amount of Rs. 2,81,90,682/- against the sanctioned estimate PAC of Rs. 1,87,39,542/- subject to the the following conditions:-

1. Surplus cut earth available on account of earth work for the subject work, if any, shall be disposed by conducting tender cum auction.
2. Proper registers shall be maintained for Bailing Out Water (Extra item No.3), duly attested by the Executive Engineer concerned.
3. Revised Technical Sanction shall be issued by the competent authority before executing the supplementary agreement.
