### ORDER

Sanction is accorded for the drawal of Interest Free Medical Advance (IFMA) of ₹ 2,00,000/- ( Rupees Two Lakhs only ) to Shri. Jenish.R.V.Raj, Accountant, Chathannoor Grama Panchayat, Kollam for his father's Coronary Artery disease treatment at Sree Chitra Institute of Medical Science & Technology, Thiruvananthapuram from the own fund of Chathannoor Grama Panchayat, Kollam subject to the conditions specified in the Government Orders read 1<sup>st</sup> to 3<sup>rd</sup> above and also subject to the conditions that utilization certificate duly countersigned by the Medical Officer of the institution should be produced within three months from the date of drawal of the amount and the loan amount should be settled within six months. In case of default penal interest @12% will be charged.

The Director of Panchayats shall ensure that necessary entries are made in the Service Book of the loanee regarding the Interest Free Medical Advance

mentioning, amount, number and date of Government Order, Contingent Bill number, date of drawal of the loan.

The Director of Panchayats should also forward a copy of the Government Order sanctioning the Interest Free Medical Advance to Government in Finance (Loans) Department after indicating the name of the treasury from where the advance is to be drawn, within one week of its issuance. Date of encashment is to be intimated. In case of Non Drawal/cancellation of Interest Free Medical Advance, the said fact may also be reported to the government without fail. Unutilized amount if any should be refunded immediately.


