### ORDER

As proposed by Sri.K.K.Narayanan, former MLA representing Dharmadam Constituency under LAC-ADS, the Chief Engineer, PWD(R&B), Thiruvananthapuram has furnished detailed estimates of the work **Improvements to Mundalur West Puthiyakavu Road from Km 0/600 to 1/000 in Peralasserry Grama Panchayat** at an estimate cost of **Rs.45,65,000/- (Rupees Forty Five Lac and Sixty Five Thousand only)** as per the reference read as 2<sup>nd</sup> paper above to accord Administrative Sanction and Special Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work **Improvements to Mundalur West Puthiyakavu Road from Km 0/600 to 1/000 in Peralasserry Grama Panchayat** proposed under LAC-ADS for the year 2015-16 of Sri.K.K.Narayanan, former MLA representing **Dharmadam Constituency** at a total estimate cost of **Rs.45,65,000/- (Rupees Forty Five Lac and Sixty Five Thousand only)** with Special Sanction to take up the work for execution as deposit work, subject to the resolution passed by the concerned Local Body in this regard, following all departmental formalities and


