### ORDER

The Hon'ble Kerala Administrative Tribunal, as per the Order read as 2<sup>nd</sup> paper above, has directed the first respondent (Government) to take an appropriate decision in the matter for the appointment of Shri.V.Gopakumar, Senior Superintendent, Regional Joint Directorate of Urban Affairs, Kollam to the cadre of Administrative Assistant/Provident Fund Officer/Pension Officer included in the approved Select List read as 1<sup>st</sup> paper above, within a period of one month from the date of receipt of a copy of the order. Accordingly, Shri.V.Gopakumar was promoted to the post of Administrative Assistant and posted at the Directorate of Urban Affairs in the existed vacancy, as per the Government Order read as 4<sup>th</sup> paper above. The Hon'ble Kerala Administrative Tribunal, as per the order read as 3<sup>rd</sup> paper above, has directed the Government to place the representation Annexure A6 by convening an Ad-hoc Departmental Promotion Committee and to take an appropriate decision within a period of six weeks from the date of receipt of a copy of the order and to keep in abeyance the filling up of the post by a regular promotion till the Departmental Promotion Committee considers the same, since the applicant in O.A.No.783/2016 was holding additional charge. It is also mentioned in the

order that the Learned Counsel for the applicant in O.A.No.336/2016 expressed an apprehension that the meeting of the Ad-hoc Departmental Promotion Committee may not be held until otherwise ordered by the Tribunal. The Hon'ble Kerala Administrative Tribunal, as per the order read as 5<sup>th</sup> paper above, has directed Government to issue order restoring status quo ante as ordered in the order read as 3<sup>rd</sup> paper above, within one week within the date of receipt of the copy of the order.

2. Government have examined the matter and are pleased to restore the status quo ante as on 07.04.2016 and the Government Order read as 4<sup>th</sup> paper above is hereby cancelled.

3. The Order of the Hon'ble Kerala Administrative Tribunal read as 6<sup>th</sup> paper above is complied with accordingly.
