ORDER

As per the reference read as 1st paper above, Government have approved the list of 40 backward Grama Panchayats, Ten Grama Panchayats having tribal clusters and Ten Revenue deficit municipalities. In the meeting chaired by the Chief Secretary held on 04.07.2016, it was suggested to constitute a Technical Advisory Group by the District Planning Committees (DPCs) for vetting and issuing Technical Sanction to Detailed Project Reports (DPRs) identified from backward Local Governments consisting of an Executive Engineer from Local Self Government Department, a Private Engineer and an Engineer from an academic institution.

Government have examined the matter in detail and are pleased to accord sanction for constituting the Technical Advisory Group by the District Planning Committees (DPCs) at the District for vetting and issuing Technical Sanction to the Detailed Project Reports (DPRs) identified from backward Local Governments with the following members.

1. Executive Engineer, Local Self Government Department.
2. A Private Engineer
3. An Engineer from an academic institution.

The Technical Advisory Group will have the powers to issue Technical Sanction for road works upto ₹.100/- lakh and for other works including building works upto ₹.250/- lakh.
