### ORDER

As proposed by Sri.Thomas Chandy, MLA representing Kuttanad Constituency under LAC-ADS for the year 2015-16, the Chief Engineer, Local Self Government Department has furnished detailed estimates of the following 2 works at a total estimate cost of **Rs.34,00,000/- (Rupees Thirty four Lakh only)** as per the letter read as 3<sup>rd</sup> paper above to accord Administrative Sanction.

- (i) Construction of Kottayil box culvert at Melpadom Marthoma Church Road in Ward 4 of Veeyapuram Grama Panchayat for Rs. 11 lakhs.
- (ii) Construction of road from Nedumudy - Kuppappuram road to Attutheeram Via south side of Orthodox pally Purayidom in Ward No. 3 of Nedumudy Grama Panchayat For Rs.23 lakhs under LAC-ADS for the year 2015-16.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction and Special Sanction for the above 2 works as Spill over works as per the circular read as 4<sup>th</sup> paper above under LAC-ADS of **Sri.Thomas Chandy, MLA** from the available balance of the year 2015-16 at a total estimate cost of **Rs.34,00,000/- (Rupees Thirty four Lakh only)** with Special Sanction to take up the work for execution, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1<sup>st</sup> paper above and subsequent Government orders.
